Who is FSC?

FSC (Forest Stewardship Council) is an independent, non-governmental, not-for-profit organization established to promote the responsible management of the world's forests. Established in 1993 as a response to concerns over global deforestation, FSC is widely regarded as one of the most important initiatives of the last decade to promote responsible forest management worldwide.

FSC is a certification system that provides internationally recognized standard-setting, trademark assurance and accreditation services to companies, organizations, and communities interested in responsible forestry.

Why FSC ?

Only FSC:

- prohibits conversion of natural forests or other habitat around the world
- prohibits the use of highly hazardous pesticides around the world
- prohibits the cultivation of genetically modified trees (GMOs)
- respects the right of indigenous peoples around the world
- controls each certified operation at least once a year – and if they are found not to comply, the certificate is withdrawn

Many of the points will appear almost basic, but in many places around the world, even these basic requirements are not fulfilled. This is where FSC can have the biggest positive impact. FSC certification helps to protect your brand and reputation and it allows you to access highly environmentally sensitive markets. Increasingly, governments and other organizations specify FSC certified products in their purchasing policies. And because FSC has the only globally valid standard, it is also the only standard that is no barrier to trade under the World Trade Organization (WTO).
